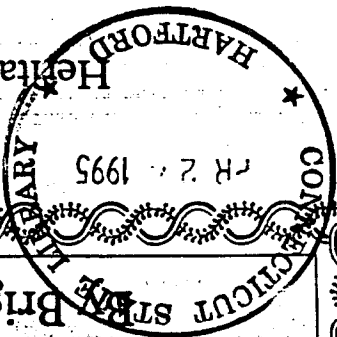

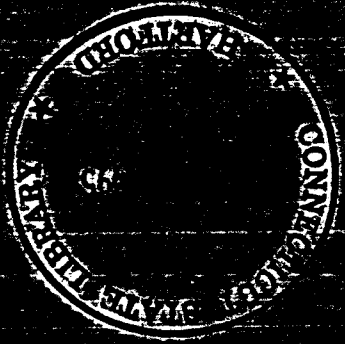

09-Aug-69 Jabez Searle died of the smallpox  
 20-Sep-69 Jabez Searl of Engine Company 6 is deceased  
 19-Apr-69 Samuel Searl & others petition to run a drain from Holyoke St  
 01-Apr-60 Capt Searle, Master of the ship 'True Britain' from Antigua has smallpox on board  
 25-Jun-72 Rev Searl is asked to join the visitation of the public school  
 21-Feb-50 Capt Alexander Sears attends the walk of the town; also on 15-Feb-51, 11-Feb-52, 16-Feb-53, 13-Feb-54, 14-Feb-55, 11-Feb-56  
 30-Apr-59 a fire at the Widow Sears' house & barn in Charter St  
 08-Sep-56 Mr Sever, lately from Rhode Island, is warned out of town  
 13-Apr-57 Mrs Lyon & child, who came last year from Rhode Island and were warned out, are to be carried out; they are now at David Seaver's in the South End  
 11-May-57 Indulgence is given for a month to Mr Seaver, his wife & children & their daughter Lyon to tarry in town, but if they do not then depart, they must be carried out  
 21-Jul-42 Samuel Sever and his wife have moved into this town from Dorchester and hired a house of Benjamin Russell  
 26-Jan-43 Samuel Sever & family from Dorchester warned out of town  
 19-Oct-63 Mr Sever has lately bought a house near the fortification which was occupied by a Retailer; he wishes to have a license to retail spirituous liquors, which is granted  
 13-Nov-71 Lucretia Seave, a poor, infirm stranger & not an inhabitant of any town in this Province, is sent to the almshouse  
 10-Dec-40 Samuel Sellen, blacksmith from London, granted liberty to open a shop in Marlborough St  
 10-Feb-47 Samuel Sellen, constable, attends the walk of the town  
 26-Dec-37 Ebenezer Selen, master of the sloop 'Whale' from North Carolina

Daniel Sergeant's wife is taken with smallpox at the Sugar House Barracks [see McDaniel's]  
 Epps Sergeant, Esq is asked to join the visitation of the public school  
 23-Jun-62 James Sergeant admitted to Engine Company 7  
 18-Jan-64 John Sergeant was appointed watchman for one of the houses with smallpox  
 10-Mar-64 John Sergeant paid for services in the smallpox  
 16-Aug-69 John Sergeant disapproved for a license as Retailer  
 09-Aug-44 John Sorten, Newbury St, disallowed as Retailer  
 12-Jul-62 Mr Sorten, baker, obstructed the search for bread by the clerks of the market  
 25-Aug-46 Mary Serrage, Newbury St, approved as Retailer  
 14-Jun-38 Rev Joseph Sewall, DD invited to the visitation of the public schools; also on 13-Jun-39, 25-Jun-40, 17-Jun-41, 24-Jun-42, 22-Jun-44, 19-Jun-45, 13-Jun-47, 16-Jun-49, 12-Jun-51, 29-May-53, 24-Jun-54, 18-Jun-55, 15-Jun-56, 13-Jun-57, 21-Jun-58, 14-Jun-59, 24-Jun-61, 23-Jun-62, 22-Jun-63, 09-Jul-64, 11-Jun-65, 24-Jun-67, 29-Jun-68

 17-Aug-37 Samuel Sewall, Justice for the county of Suffolk residing in Boston  
 17-Jun-41 Maj Samuel Sewall invited to the visitation of the public schools
